Julia: Have concerns about the rebranding strategy on the Gulch. Not concerned because of my business name, but because downtown Helena needs efforts market it. I do see the wayfinding is included work plan but no budget for this. Name change is a big deal and needs leadership, so probably not a good time to do this. Also, concerned about the conflict of interest. Needs to have disclosure and more care taken on how this happens, especially recusing from conversation and vote. Would encourage to do limited solicitation after new ED on board, and can open to others in the downtown. Really need to focus on finding a permanent ED, believe in this organization and want it to succeed.

Seth: Yes, everyone does sign a state of conflict of interest. And our funding is through tax levy on **building** owners

Alice: We did go out to bid on the original contract

Seth: This is just an extension of the original contract. And will be open at the end of 6months

Julia: \$12k for 6 months?

Peter: Farmer's market doing well - demand for the market is there. Double SNAP benefit program open, setting records in the dollar amounts of food benefits we are able to provide. 9 non reserved out of almost 200.

Onawa: Do you still have a free space for kids wanting to do business? My kids have Pop Cycle.

Peter: we are easy we can make something work.

Andy: Can talk about this at farmer's market a board meeting.

Kev: Have an idea. Queer community wants to find their people not at a bar, the Book store does that defacto but need a different space. What if pride and BID came together, split the salary, used this space as a community space, and the ED became the go to for working with the city for events and could cover event insurance? BID would get an ED, DHI work would continue, and pride would have a space for the community.

Onawa: Would be ED split between the orgs?

Kev: Yes, are you interested in trying it?

Alice: could you put it in a bullet/job description?

Seth: We share the space with the bookstore and kevin league, and trying to get 2 full time positions filled right now.

Onawa: Also talking about joining with the chamber and visit Helena at the chamber building.

6. City of Helena Update

Emily: Admin meeting tomorrow, there is a new transportation plan for the capital area that might interest this group. Callie sent some very helpful public comments. Sounds like there's some difficulty communicating with GSA at capital. Heard about a water shut off on walking mall - private contractor that was required to contact surrounding businesses, it will be at the US Bank building at 7pm. Fire service line, not all water access. City working with contractor to give better information to the surrounding business. August 7th, the entities that received ARPA funds will give presentations to the city at admin meeting. BID should be getting an update on the public restroom in Constitution park.

Transportation plan – state and city have been trying to accommodate traffic around the capital. Put in one ways around the capital. East bound on 6^{th} and the loop back around, would accommodate angle parking.

Onawa: do a lot of residents complain during the session about parking?

Emily: Not really. Get more complaints about the snow removal piece.

Megan: Summarize callie's concerns, I'll be at admin meeting

Emily: I think it will be good to get everyone in the same room, it sounds like that will help that.

Messaging slightly changed, used Visit Helena colors. After 6months, will go out for bid again for services for BID.

Julia: have the other's online seen the contract? Shouldn't they see it before the vote?
